## APPLICATION & TESTING PROCESS

### Notes:

- Candidates who wish to have their walling skills examined for certification by the Association should read and fully familiarise themselves with this booklet, *DSWA/Lantra Awards Accredited Craftsman Certification Scheme* before completing this form.
- It is the candidate's responsibility to ensure the test requirements are understood.
- Application and payment must arrive no less than six weeks, prior to the test date. Please remember to sign the form.
- Cheques should be made payable to DSWA (GB) or alternatively complete the credit card payment section on the form. Payment can also be made via the DSWA website, in the Craftsman Certification Scheme section, under the Training heading, using PayPal or credit/debit cards.
- Mark sheets are not issued to Examiner(s) until fees and forms have been received and processed.
- Tests at Level 1/Initial and Level 2/Intermediate must take place in groups of at least six candidates: the group can include candidates for both levels of test, as well as candidates for Level 3/Advanced and Master Craftsman.
- Tests for Level 3/Advanced and Master Craftsman are two part tests. **Part A must be completed and passed before an application can be accepted for Part B.** All timed tests (Part B) will be taken as part of a pre-arranged test day.
- Personal data will be stored in a computerised system. Information on an individual's certification level will be provided on request. An individual may obtain a copy of their personal records by submitting a written request, together with a fee of £5, to DSWA.
- Refunds are not normally given unless under exceptional circumstances.
